All submitted manuscripts should contain original work neither published previously nor under consideration for publication elsewhere. Articles shall be accepted from any country provided submitted in English language only. There is no page limitation for articles; however authors must strive to present their results as clearly and concisely as possible. Authors, in their cover note to Editor, shall have to clearly mention whether the manuscript is to be considered as a Research article, Short communications or a Review article.

Submission of Manuscript

Authors may submit the articles only through the online manuscript submission submit a Paper system. Authors are advised to submit the articles as MS Word 2003 or 2007 format only with the pdf copy.

Language

Language of the articles should be only in English, we are not processing articles in any other languages.

Font Size and Font type :

Heading and subheading should be in Times roman Style and 12 Font Size . All the footnotes (i.e. tables no, figures no , graph no) should be in 11 font size.

Submission Order:

The following order should be strictly followed while submitting the article:

Manuscript Preparation Guidelines

Page 1 – Title Page:

Include the **title of the article (14 font size , Bold and Caps)**, **names of the authors** , and their **institutional affiliations** only..

Page 2 – Abstract and Keywords:

Begin with an **abstract** of approximately **200–400 words**, clearly summarizing the content of the article. Follow the abstract with a list of **keywords** relevant to the work.

Introduction

The introduction should clearly outline the background and importance of the study. It must reference current and relevant literature, particularly the most recent publications, to justify the need for the research. Emphasis should be placed on identifying knowledge gaps the study aims to fill.

Materials and Methods

This section should provide concise yet comprehensive details of the materials, instruments, and methodologies used in the study. All analytical, experimental, and statistical procedures must be described with clarity and precision, ensuring that other researchers can replicate the study without ambiguity. Standard protocols should be referenced, and any modifications must be clearly specified.

Results

Results should be presented in a logical sequence, using tables and figures where appropriate. Data presented in tables should not be duplicated in figures, and vice versa. Avoid extensive repetition of numerical data in the text. Summaries of the key findings should be provided without unnecessary elaboration.

Discussion

The discussion should interpret the findings with direct reference to the presented tables and figures. It should critically evaluate the results in the context of previously published literature, highlighting the study's contributions to the field.

Acknowledgements

(If applicable) This section should briefly acknowledge any individuals, institutions, or funding bodies that contributed to the research but did not meet authorship criteria.

References

References should be listed in the order in which they appear in the text. For works with three or more authors, list only the first author followed by "et al." References of journal articles, books, chapters in books, etc. should be cited, as follows:
